Tuberculin Mammalian, Human Isolates Intradermic

Tuberculin, Mammalian, Human Isolates, Intrademnic is prepared from culture filtrates of Mycobacterium tuberculosis (strain Prr. C. and Dt) which are heat-inactivated and concentrated to 40% of their original volume by evaporation. The culture are grown on a synthetic media and tested in accordance with U.S.D.A. requirements Caution: This product contains total and TCA precipitable nitrogen levels below those specified in Title 9, CFR Part 113.406. However, present levels are approved. Dilution prior to use is not recommended.

INDICATIONS: 1. For intradermal testing of non-human primates for mammalian tuberculosis. 2. This is <u>not</u> for testing cattle for **bovine** tuberculosis. To test cattle for bovine tuberculosis use PPD Bovis, Intradermic.

EQUIPMENT: Intrademic tuberculin syringes graduated in hundredths of a ml and equipped with a 26 gauge needle, 3/8 inch in length. The needle should be deaned with alcohol and dried before each use.

DIRECTIONS: Intradermic Test: For non-human primates, follow the procedure recommended in the current "Laboratory Animal Management: Non-human Primates" — National Academy Press, or equivalent. If skin is clean, it is not necessary to disinfect or otherwise clean the surface. Solide skin should be cleaned with cotton, either dry or moistened with 50% aclosed. Strong disinfectants must not be applied near the injection site, Care must be taken to ensure that all traces of alcohol are removed from both the injection site and neede prior to each injection. This is necessary to avoid any inflammation from the disinfectant which might be mistaken for a reaction.

A positive reaction is indicated by an induration (swelling) of the skin at the site of injection. The test should be interpreted at 72 ± 6 hours by palpation and observation (additional observations may be made at 48.96 and 120 hours).

CAUTION: Store in dark at 35°-45°F (2°-7°C). Protect from freezing. This test should not be repeated at less than 60-day intervals. Veterinarians interested in the use of this product should contact regulatory officials within their state or country for specific directions and legal requirements pertaining to its use.

PRECAUTION: This product has been tested under laboratory conditions and shown to meet all Federal standards for safety and use in normal healthy animals. This level of performance may be affected by conditions of use such as stress, weather, nutrition, disease, parasitism, other treatments, individual idiosyncrasies or impaired immunological competency.
